

TED WIENS TIRE AND AUTO CENTER LIMITED WARRANTY

All requests for adjustment must be accompanied by a **TED WIENS TIRE AND AUTO CENTER** sales receipt and guarantee form where applicable. **TED WIENS TIRE AND AUTO CENTERS** offers a 2 year/ 24,000 mileage warranty on parts and a 1 year/ 12,000 mile warranty on labor. Warranties for Commercial Vehicle and Vehicles for Hire are limited to a 1 year/ 12,000 mile warranty on parts and a 6 month/ 6,000 mile warranty on labor. (year/ mileage is whichever occurs first)

MATERIAL DEFECTS: TED WIENS TIRE AND AUTO CENTER guarantees every tire it sells against defect in material and workmanship in accordance with the manufacturer's warranty. See store for details.

MILEAGE: Some passenger car tires have mileage guarantees which will be covered on a pro-rated basis and for the number of miles specified, provided the tires do not show signs of unusual wear caused by misalignment, imbalance, mechanical defects, improper inflation, or deliberate abuse, information as to which tires carry mileage warranties is available upon request. Mileage warranty are manufacturers where applicable.

ROAD HAZARDS: Most manufactures no longer guarantee their product against road hazard. However, **TED WIENS TIRE AND AUTO CENTER** has available at slight additional cost a road hazard protection policy. Ask about our tire protection plan.

GENERAL: Should adjustment become necessary, the tire in questions **MUST** be returned to **TED WIENS TIRE AND AUTO CENTER** for inspection. If the warranty is applicable to the tire in question, an allowance will be made. All adjustments will be made on a pro-rata basis, based on remaining tread or remainder of warranty mileage (where applicable) at **TED WIENS TIRE AND AUTO CENTER'S** option and will be made in the form of a cash refund or credit towards another tire at **TED WIENS TIRE AND AUTO CENTER'S** option. This warranty is limited to tire replacement only and does not cover road hazards, consequential damages, or costs of mounting, dismounting, or replacing. (Some states do not allow the exclusion of limitation of incidental or consequential damages, so the above limitation may not apply to you.) No **TED WIENS TIRE AND AUTO CENTER** representative has authorization to make statements or promises other than those stated within this warranty. This warranty gives you specific legal rights, and you may also have other rights which vary from state to state.

NATIONWIDE SERVICE REPAIR LIMITED WARRANTY

This limited warranty is extended only to you, the original purchaser, and not to anyone who may purchase your vehicle from you during the term of the warranty. This limited warranty is made by the Independent Repair Facility ("Facility") who is so named on the original repair invoice and performed the service/repairs on your vehicle. This warranty may be honored by other facilities participating in this program, or other authorized non-participating facilities anywhere in the United States. Automotive Business Solutions, Inc. serves as the administrator only.

WHAT IS COVERED BY THE LIMITED WARRANTY

This warranty covers the following types of repairs and services, subject to the exclusions listed within:

- Air conditioning, heating, and climate control systems
- Brake system
- Engine cooling system
- Electrical system, including the starting and charging systems
- Engine performance, drivability services and repair
- Electronic engine management systems and on-board computer systems, (engine, body, brake and suspension computers)
- Steering/suspension system, wheel bearings, CV joints/U-joints, Half-shafts, and driveshafts.

TED WIENS TIRE AND AUTO ROAD HAZARD POLICY

With Ted Wiens' Nationwide Tire Protection Plan, your tire repair or replacement is reimbursed (to the extent and subject to the conditions, provided in the Program Certificate). Tires are covered for 36 from the date of purchase or until 2/23" or less of tread remains, whichever occurs first.

- Repairs are reimbursed up to \$20 per tire occurrence.
- During the first 33% of useable tread wear, you will be reimbursed for 100% of the original cost of the tire covered by the Nationwide Tire Protection Plan, subject to the limitations set forth in the Program Certificate. Beyond the first 33%, you will be charged for the consumed useable tread

wear on the original tire times the original selling price of the tire. When the tread is worn down to 2/32" the tire is considered worn out and is not eligible for adjustment.

- You will be responsible for any taxes, mounting, balancing, and any other miscellaneous fees. Consequential and incidental damages are excluded.
- Flat Tire Changing Assistance is available for 36 months. Some restrictions apply, see the Program Certificate for details.
- The following tires are not eligible for the Nationwide Tire Protection Plan:
 - Competition tires
 - LT Metric sized tires used on commercial vehicles
- The following vehicles are not eligible for the Nationwide Tire Protection Plan:
 - Any emergency service vehicle.
 - Any vehicle used for hire, commercial, towing, construction or postal service.
 - Any vehicle used for farm, ranch, agriculture, or off-road use.
- Additional exclusions and limitations are described in the Program Certificate.
